

TERMS AND CONDITIONS FOR 'DISHKIYAON CUP' CONTEST

1. These terms and conditions shall govern the 'Dishkiyaon Cup Contest' (hereinafter the Contest') conducted by Dish TV India Limited (the 'Company').
2. The Contest shall run during the period of the Cricket World Cup 2019 and shall be open only for the subscribers of the Company using either 'dishtv' or 'zing' connection (Subscribers).
3. The employees and their family members of the Company, its associate companies, trade partners, advertising and promotional agencies and auditors / executing agencies are not entitled to participate in the Contest. Minors are not allowed to participate in this Contest.
4. By participating in this Contest, the participant agrees to accept the terms and conditions of the Contest.
5. No purchase or payment is required to participate in this Contest. Participation is voluntary.
6. During the term of the Contest, the Company will assign one number each to each of the teams participating in the Cricket World Cup 2019. A participant shall be required to predict the winner of the match being played between two countries by giving a missed call at the number assigned to the said team from his Registered Mobile Number (RMN), or by logging on to the Company's website www.dishtv.in and giving the prediction there.
7. The Contest shall comprise of three categories of prizes for (i) daily fastest predictions, (ii) five correct predictions (high five) and (iii) fastest and maximum correct predictions (Star of the Tournament).
8. To predict the winner of any match (daily predictions), a participant needs to give a missed call at the number assigned against the respective participating team from the RMN or log on to the company's website and choose the winner from the participating team. The prediction window shall open 24 hours before the match i.e. 3:01 PM of the previous day and shall close at 3:00 PM of the scheduled date of the match or 6:01 p.m. of the previous day and shall close at 6:00 p.m. of the scheduled date of the match (as the case may be as per the Cricket world cup schedule).
9. Upon giving the prediction, participants will get confirmation about their participation through SMS on their RMN.
10. In case of multiple entries by a participant for a particular match, the last recorded prediction will be counted as final.
11. The 10 quickest correct predictions (daily predictions) shall be eligible to get one month (30 days) free subscription from the Company on their existing packs. The participants shall be eligible to win under daily prediction only once during the term of the Contest.

12. Every five correct predictions shall make the participants eligible to win 10% cash back on their next recharge. A participant can win maximum 30% cashback during the entire term of the Contest. Cashback has to be availed on or before 15th August 2019.
13. 10 fastest and maximum correct predictions at the end of the contest, shall be eligible to get one year (360 days) free subscriptions on their existing pack.
14. By participating in the Contest, the Participant gives the right to the Company to use and publish their names and images on its website and other promotional materials as the Company may deem fit.
15. Company shall not be liable in case the winner fails to avail the benefits of the Contest as per the defined terms and conditions
16. If the DTH connection of the winner gets terminated on account of piracy of signals of dishtv/zing, the winner shall not be eligible to get the prize benefits.
17. Company may substitute or change prize under the Contest at any time without notice. The Winner shall not be entitled to substitute the Prize for other item(s) or exchange for cash. Prize shall be non-transferable.
18. Winner shall be declared on the Company's website, on the interactive channel of the Company, through SMS or through any other mode as the company deems fit. The Company will subsequently contact the winners by sending messages to them on their RMN and can seek personal information viz. contact address, identity proof, pan card details, phone number, etc. Identification considered suitable for verification.
19. By participating in the Contest, each Participant agrees that Participant's name, address, telephone numbers, e-mail identities or any other information that is provided by the Participant ("Personal Information") may be shared by the Company with others associated with and/or assisting in organizing and administering the Contest, and to send to the Participant promotional information pertaining to the Company, in future.
20. All taxes, levies and duties due and owing under applicable and statutory laws in connection with all the winnings, if any, are the sole responsibility of the Winner.
21. In the event of a death of the Prize Winner, no claim from the nominees or legal heirs of the Prize Winner shall be entertained for receiving the Prize.
22. Decision of the Company will be final and binding with regard to the Contest, declaration of Winner and Prize and no correspondence, objection, complaints, etc. shall be entertained in this regard.
23. This Contest cannot be clubbed with any of other contest/contests that are running simultaneously.
24. The Contest is subject to force majeure conditions.
25. The Company reserves the right to change/modify/or withdraw the Contest without any prior notice of the same at its sole discretion. The Company reserves the right to modify the terms and conditions without any prior notice.

Participants shall be solely responsible for any costs and expenses incurred towards internet connection charges, e-mail transmission charges, data transfer (send/receive) charges, mobile connection charges or other incidental costs or expenses as may be applicable, inclusive or exclusive of any other service charges, applicable taxes, levies, duties, cess, etc. depending upon the service provider.
27. Mere participation in the Contest does not entitle the Participant to win the Prize.
28. In case of a tie/ draw or the match is cancelled or abandoned due to rain or the match result is inconclusive due to any reason, no prizes will be declared for the entries received for such match

Company assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line-failure, theft or destruction or unauthorized access to, or alteration of, entries. Company shall not be responsible for any problems or technical malfunction of any telephone, telephone network or lines, computer on-line systems, servers, or providers, computer equipment, software, failure of any entry to be received by Company on account of any technical problems or traffic congestion on telecommunication service provider's network / system, the Internet or at any web site, or any combination of them, including any injury or damage to any Participant's or any other person's computer related to or resulting from participation or downloading any content or material for Contest.

33. This contest is not valid for the Subscribers of the State of Tamil Nadu and wherever prohibited and is subject to all applicable mandatory national and state laws.

Regardless of location of Participant/Winner, all activities in relation to Contest, these Rules, Terms and Conditions of Contest and any disputes arising from or in relation to Contest or to participation in Contest or interpretation of these terms shall be governed exclusively by the laws of India (including tax laws, rules and regulations as may be applicable from time-to-time). Each Participant agrees to submit to the exclusive jurisdiction of the Courts of law at Delhi.
