

# TERMS & CONDITIONS

1. These terms and conditions apply to the “Dish TV website Contest” (hereinafter referred to as “the Contest”) organised by Dish TV India Limited (‘Dish TV’).
2. By entering the Contest, entrants accepts these Terms and Conditions together with any other specific instructions which may be communicated to the entrant in any other way.
3. Participation in the Contest is voluntary.
4. The Contest is open for the citizen of India residing in India only, having attained the age of 18 years as on the date of participation in the contest, except the employees and the family members of the organizer, its associate companies, its advertising and promotional agencies and its auditors / executing agencies their associate companies (“Contestant”).
5. The Contestants must be a ‘DishTV’ subscriber and recharge his ‘DishTV’ DTH connection for any amount to be eligible to be part of the Contest.
6. However, residents of the state of Tamil Nadu, Karnataka and residents wherever prohibited by virtue of prevailing law, shall not be entitled to participate in the Contest and/or lucky draw, if any.
7. The Contest shall be open from January 11<sup>th</sup>, 2020 to January 18<sup>th</sup>, 2020 (hereinafter referred to as ‘Contest Period’).
8. Under the Contest, a Contestant having recharged his ‘DishTV’ subscription by a maximum amount in any day during the Contest Period shall be chosen as the winner for the said day. Winners shall be determined from all the recharges done for the day by a computerized process and the result declared by Dish TV shall be final and binding and no correspondence shall be entertained in this regard.
9. Winners shall be entitled to a couple movie ticket of the movie “DoLittle”. Redemption method will be shared after the contest is over. Dish TV shall not be responsible in case any cinema hall/theatre situated in the city/town where the Winner/s resides is not covered in the list of theatres.
10. Only successful recharge on Dish TV website ([www.dishtv.in](http://www.dishtv.in)) and DishTV Mobile App (My DishTV) will be considered for the Contest. In the event of any fault, mistake or dispute concerning the correctness of the recharge by the entrant, the decision of Dish TV shall be final and binding.
11. Upon declaration of the result, the winners shall be contacted through phone or such other means as the Company may deem fit. The winner has to confirm his name, Viewing card number and address to be entitled for the prize.
12. All decisions with respect to the Contest shall be at the sole discretion of Dish TV and the same will be final & binding on a non-contestable basis.
13. Prizes are non-transferrable and cannot be exchanged for cash. No cash claim can be made in lieu of prizes. Dish TV shall not be liable for any direct or indirect loss or damage

15. Any dispute arising out of or in connection with the Contest shall be subject to the exclusive jurisdiction of the Indian courts only based out of New Delhi. The existence of dispute, if any, shall not constitute a claim against Dish TV.
