(2) Preferential allotment of 1,900,000 Equity Shares each to Shree Dhoot Trading And Agencies Limited, V N Dhoot Investment Company Private Limited (now Solitaire Appliances Private Limited), Keshar Dhoot Investment Company Private Limited (now Greenfield Appliances Private Limited), R N Dhoot Investment Company Private Limited (now Synergy Appliances Private Limited) and Dome-Bell Electronics India Private Limited; and 450,000 Equity Shares to Dhoot Brothers Investment Company Private Limited (now Platinum Appliances Private Limited).

(3) Allotment on rights basis of 32,680,000 Equity Shares each to Shree Dhoot Trading And Agencies Limited, Solitaire Appliances Private Limited, Greenfield Appliances Private Limited, Synergy Appliances Private Limited and Dome-Bell Electronics India Private Limited; and 8,600,000 Equity Shares to Platinum Appliances Private Limited.

(5) The Company has allotted 150,999,600 equity shares of face value of Rs 10/- each at a premium of Rs 102.92 per share on 31st March, 2015 to the Depository (Deutsche Bank Trust Company Americas). The depository in turn has issued 37,749,900 ADS. Each ADS represents 4 equity shares of the Company.

(6) Allotment on Bonus basis of 4,438,400 Equity Shares each to Shree Dhoot Trading And Agencies Limited, Solitaire Appliances Private Limited, Greenfield Appliances Private Limited, Synergy Appliances Private Limited and Dome-Bell Electronics India Private Limited; and 1,163,328 Equity Shares to Platinum Appliances Private Limited and 2,336 Equity Shares each to Mr. Venugopal Nandlal Dhoot and Mr. Anirudha V. Dhoot.

(7) The company, under ESOP Plan 2014, has given an option to its eligible employees entitling upto 4,000,000 equity shares. Each option pursuant to the ESOP Plan 2014 entitles the grantees to apply for one equity share. The exercise price is Rs 50 per option. So far the company has granted option of 3,705,000 equity shares and the grant is administered by ESOP Trust named Videocon d2h Employee Welfare Trust.
